## ...a place bursting with kindness and love

fter my father's death in May 2004, I felt my life could never be the same. I just wanted everything to go back to normal. I was so tired of the sad looks, the long faces. I was tired of people telling me "Keep hanging in there, Sarah." I was tired of other people doing us favors, bringing us food. I was tired of being someone's charity case. I was angry, angry at what had happened. And worst of all, I was mad that there was no one to whom I could really talk. I just wanted everything to go back to normal.

A few months after my father's death, my mom suggested going to The Center for Grieving Children. My brothers and I were strongly opposed to the idea, for sitting around and talking about what happened didn't exactly appeal to us. My mom's deal was to go four times and get candy after each one. She never could have imagined how much candy that would turn out to be! We agreed to go, and after the first night we all knew we would be there for much longer than four weeks.

I remember my first night. I was only 11, about to enter 6th grade. I was so nervous, so scared that I would hate this place, that I would never want to come back again, yet once I met my facilitators and the two other girls in my group, I softened up and tried to enjoy myself. I was lucky; my group consisted of me and two other girls all my age! We immediately hit it off, and the three of us formed a close bond that held our group together through the coming months.

At school, I couldn't talk about what happened. All the emotions were wound up in my head, and I had nowhere to let them out. My friends didn't understand and I didn't want to upset my family. I felt like I was the only one. I just followed the same routine I had in past years, yet it was always obvious something was missing. Once I started going to The Center, I met people in a similar situation. The two girls in my group had also each lost a parent, and they were experiencing similar feelings. It felt so good to just talk.

Although our group spent a lot of time talking, we also had a lot of fun. We brought in some sort of food (usually candy) almost every week, and we had a lot of parties. One week we would go a nearby playground, the next we would decorate cupcakes. We shared our highs and lows, and I felt I could tell my group anything. I was so excited to show my group pictures of my family and my father. I became interested in the lives of other people, and I looked forward to seeing them each week. I particularly loved my trips to the volcano room, where I could rip up phone books for five minutes until the entire room looked like a snow globe of yellow and white paper.

Going to The Center gave my family peace and a time to relax, something that was often forgotten in our busy schedules. We had the best conversations in the car rides home. Each week we left the Center happier and distracted from our often stressful lives.



Everyone at the Center had a story, a reason why they were there. Many of the volunteers were once visitors just like us. About a year before he died, my father told us how sad he was about the death of the 2 ½ year old son of one of his coworkers. It was very touching to meet this child's father, Mr. Libby, volunteering at The Center. I felt welcomed at the center, and so happy that someone cared. One week around Christmas, my brothers and I each came home with a brand new teddy bear and a homemade quilt. To see that someone cared enough to give us those gifts really made me feel much better.

Although it is called The Center for Grieving Children, my mom really enjoyed it too. She could talk to other adults who had lost spouses and children, and she met many people feeling just like her. It was nice to come in each week and see all these families just like us who were so glad to be there. I think the Center helped my mom recover just as much as it helped us children.

When we graduated from The Center, I felt that I had changed a lot. The Center gave me much more confidence and pride, which has proved so helpful throughout my middle school years. The Center taught me to accept my father's death and to remember him. For my two younger brothers, I know The Center helped them keep their memories strong. We can now talk about my dad without any discomfort, and my brothers feel comfortable asking questions. Going to The Center helped preserve my wonderful memories of my father so that I will keep them in my heart for years to come. The Center for Grieving Children is a truly brilliant place for which I will always be thankful. It is a place bursting with kindness and love.

## Love Really Counts

The qualitative impact of our work is well understood by those who have been touched by The Center for Grieving Children. What is perhaps not as well understood is the impressive numbers behind the incredible services that our staff and volunteers provide.

Here, in a quick snap shot, is a summary of our services by the numbers:

During the fiscal year ending June 30, 2006 our volunteers provided almost 23,000 service hours via program delivery, special events assistance, office work, and board service. Last year we served more than 650 children and over 1560 adults through a range of programs and services and none of it would be possible without the generosity of our financial supporters or the tireless energy of our volunteers.

Last year our Bereavement Peer Support Program served more than 100 families including 29 children, 78 adults through weekly peer support groups with 10,230 service hours delivered by volunteers to those grieving the death of a family member or friend. In this last year we also added our new Bereaved Parent Support Group in partnership with Maine Medical Center.

35 children and 27 adults from 20 families were served by our Tender Living Care program and more than 1,900 volunteer service hours were given conducting phone support, home visits and weekly peer support groups for children, teens and their families coping with a serious or life threatening illness.

Our Multicultural Peer Support Program continued to serve those children and their families who have relocated to Portland from war-torn countries having experienced multiple and/or traumatic loss. Last year we delivered services to 32 elementary and middle school pupils through 3,116 volunteer service hours.

1456 adults and 455 children were reached directly by our Community Outreach and Education Program that provides support during times of crisis in schools and communities.

The Center for Grieving Children provided Outreach and Professional Training to more than 40 schools and community agencies, new or established grief support programs, and other community agencies from states as far a-field as Alaska and Arkansas. In addition each year we conduct our Annual Training Institute for other Centers nationwide.

For many people The Center for Grieving Children is the first place they call when loss or illness affects their families and loved ones. In addition to The Center based peer support programs we offer, we also serve hundreds of families on the telephone and via the web by providing consultations, program descriptions, support materials, referrals and phone support to families, schools and other agencies.


Last year our Bereavement Peer Support program handled more than 680 calls and provided over 1,500 services to community members dealing with loss and grief.

In our Tender Living Care program we supported more than 600 calls and provided over 1,100 services to those requesting information and support on dealing with a family member with a serious or life threatening illness.

Our Community Outreach and Education program responded to hundreds of requests for information and provided educational and crisis support services to almost 2,000 individuals, families, schools, agencies and other centers.


# 2005-2006 Program Statistics

Volunteer Service Hours 2005-2006




