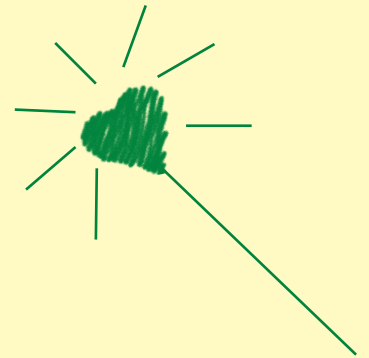

By the Numbers



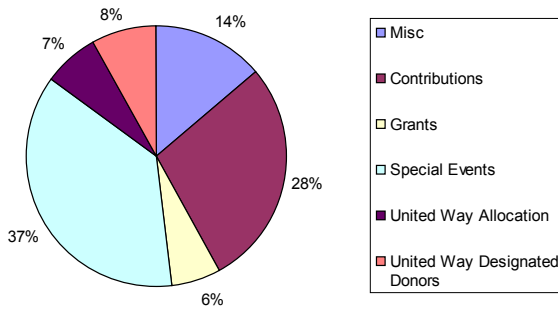
Research indicates that one child in 20 will lose a parent before the age of 15. Add to that those who will lose a close family member, a friend, or a teacher, and the numbers grow dramatically. The loss of parent, sibling or close friend can impact the emotional and mental health of a child. The short and long term impact of unsupported grief speaks more loudly than ever to the need to find innovative and cost-efficient ways of supporting children at an early stage in their grief process. Giving them the opportunity to share their feelings and break down the wall of silence that surrounds grief leads to healthy emotional development and fosters resilience.

Since 1987, The Center for Grieving Children has provided a place where children, teens and families can come to begin the process of healing with the support of friends, families and highly trained volunteers for as long as they need at no charge.

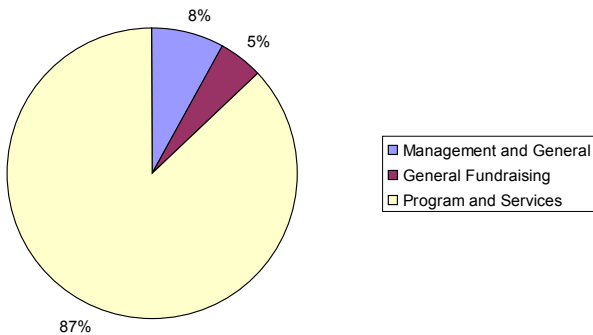
- Children (ages 3-18), their families and young adults (ages 19-30) who have suffered the loss of someone close participate in the core Bereavement Support Program. Last year our Bereavement Peer Support Program served 181 children, 77 adults, 13 young adults and more than 100 families through weekly peer support groups with 10,860 volunteer service hours.
- Families facing serious illness are helped through the challenges they must live with in the Tender Living Care Program. In 2009-10 we served 40 children and 37 adults from 25 families with 2,647 volunteer service hours.
- Members of Portland's immigrant population who have fled parts of the world undergoing severe conflict are helped in the Multicultural Program, an after school program for elementary and middle school aged children. In 2009-10, we served 37 students from Portland Public Schools through more than 2,300 volunteer service hours.
- Schools and communities are served through our outreach programs when a traumatic loss has occurred. The Center provides training, information and personnel to help organizations and individuals deal with grief issues, especially the impact on children, in a school setting. Last year 1,954 adults and 1,092 children were reached directly by our Community Outreach and Education Program that provides support during times of crisis in schools and communities.

The Bolster Family

In January 2010, Susan Bolster was diagnosed with Stage 4 Colon Cancer. The diagnosis was a complete shock to her family...she was living a normal, healthy life and was having no symptoms. Susan and her husband Jay quickly realized that they needed help talking to their two young daughters about her cancer diagnosis. The Center was there for her family as they went through the process of telling their daughters and other family members about her illness.

A few weeks after the diagnosis, The Bolster's started attending The Center's Tender Living Care (TLC) program. The TLC program is a program for families facing a serious illness. They enjoy being with people who are going through similar struggles. When they are at The Center they no longer feel alone and

are able to talk to other people who "get it". Jay, the Dad, is in the caregivers' group and he is able to learn from others and share his experience. He has been able to share a range of emotions from sadness to laughter.

The Bolster's four year old daughter, Quinn, also attends The Center. Quinn loves coming to The Center and playing dress up and jumping in our huge pile of stuffed animals. She has made a lot of friends. She and her parents feel that The Center has helped to "normalize" things for Quinn.

The Center has given the Bolsters a community to be part of where they can come and work through their struggles. When they are at The Center, they feel supported and nurtured by the Tender Living Care program. They have been able to receive immediate support right from the point of diagnosis.
